The Twins Scholarship

As evidence of Lake Erie College's responsiveness to the desires of our alumni and students, we have reinstated the Lake Erie College **Twins Scholarship**. This **FULL TUITION** scholarship (up to 18 credit hours per semester) is awarded to the second twin if both are enrolled as full-time, undergraduate students at Lake Erie College. In essence, both twins can attend LEC for the tuition cost of only one.

Lake Erie College Alumni Scholarship

We are committed to ensuring that you do not exclude Lake Erie College from your future due to the perception that a quality, private education is too costly. If we accept you to the College as a regularly admitted, full-time, degree seeking, undergraduate student, you will receive a **Lake Erie College Alumni Scholarship**. The amount of this award is based on your academic performance and your direct cost of attendance.



Margery Ainsworth Endowed Scholarship Fund

Margery Ainsworth, a 1925 graduate of Lake Erie College, served the College for 51 years as bookstore manager, assistant to the treasurer, recorder and registrar. In 1983, Margery retired at age 81. She received an Honorary Doctorate of Humane Letters from the College in 1976. In 1981, Margery earned the Distinguished Alumni Award. A sundial located in a small garden between College Hall and Austin Hall of Science was dedicated to her when she retired, and she was given the title of Registrar Emeritus.

In 1986, the National Alumni Board established the **Margery Ainsworth Endowed Scholarship Fund** to recognize Margery's many years of service to the College. Scholarships are awarded each year to deserving students who are the daughters or sons of College alumni.



Karl B. Bernal Scholarships

As a local community leader, Karl B. Bernal spent his life giving and providing service to many civic organizations. After Karl's death in 1997, family members and friends established The Karl B. Bernal Memorial Fund at the Cleveland Foundation to perpetuate his good works. The fund provides financial support to the Lake County Society for Rehabilitation and to Lake Erie College.



Karl B. Bernal Scholarships are awarded annually to qualified students from Lake, Geauga and Ashtabula counties. Preference is given to students with disabilities.



Mary Evans- Luette P. Bentley Scholarship

From 1868 to 1909, Mary Evans was principal/president of Lake Erie Seminary/College. As a graduate of Mt. Holyoke Seminary, she believed in educating the body, mind and spirit of all the female students who studied under

her leadership. She was intent on preparing young women for service and happiness in the home, the state, and the kingdom of God.

Luette Bentley, an 1865 graduate of Lake Erie Seminary, served the seminary as teacher, assistant principal and dean from 1865 to 1909. Together, Miss Evans and Miss Bentley guided the College for over 40 years. They had tremendous influence on higher education for women in this part of the country.

The Cleveland Alumni Association awards the **Mary Evans-Luette P. Bentley Scholarship** to a graduate of a secondary school in the Greater Cleveland area. The student must have a cumulative grade point average of 3.0 or better and must reside on campus.



Lorraine Blaylock Scholarship

Lorraine Sterkel Blaylock, a 1942 graduate of Lake Erie College, was a Women's Air Force Service Pilot (WASP) during World War II and a Red Cross volunteer for over 25 years. Lorraine and her husband William traveled extensively between 1961 and 1992. During their 25 foreign trips, the Blaylocks spent 1,144 days out of the United States.

After Lorraine's death in 1995, William wrote that the College opened up countless vistas for her future. "She spent four happy years at Lake Erie College and throughout her life exemplified everything expected of a Lake Erie graduate." In 1996, William F. Blaylock established the **Lorraine Blaylock Scholarship** in memory of his wife. This scholarship is awarded annually to a senior female who has a grade point average of 3.0 or above and is majoring in the liberal arts.





The Bonte/ Dahlgren Equestrian Studies Book Award

Mary-Lu Bonte graduated from Lake Erie College in 1976. She earned a bachelor's degree in human movement with a minor in equestrian studies. Following graduation, Mary-Lu worked for two years as a riding instructor for Robert Hall's Fulmer Riding Schools in Great Britain.

After her return to the United States, Mary-Lu worked in the local, state, national and international levels of the Special Olympics. She served as the first Director of Equestrian Sports for Special Olympics International. She now works for FairMount Farm Equine Services in Greenville, South Carolina. FairMount Farm offers at-home care and services for the private horse owner and an on-call transport service for local veterinarians' clients. In 1992, Mary-Lu was an Interface Alumni Lecture Series participant. She was nominated for the Lake Erie College Distinguished Alumni Award in 1997.

The Bonte/Dahlgren Equestrian Studies Book Award is presented annually to a sophomore. Through their enthusiasm and dedication, the award recipient must demonstrate their great potential to become a well-rounded and dedicated equestrian. The student is to use the award to purchase a book for his or her personal library.



Sarah Porter Bosworth Living Endowment Fund

Sarah Porter Thorne Bosworth graduated from Lake Erie College in 1913. For five years following graduation, she taught English at Lakewood High School. Sarah lived in Lakewood for 60 years and was a vocal soloist at the Lakewood Methodist Church. Sarah also served on the board of trustees of Lakewood Public Library. In 1976, Sarah earned the Distinguished Alumni Award. She died in 1983 at age 93, surviving husbands George Thorne and Herbert H. Bosworth.

Sarah was president of the Lake Erie College National Alumni Board, an alumni trustee and member of the Cleveland Alumni Club scholarship committee. In 1964, the Cleveland club established the **Sarah Porter Bosworth Living Endowment Fund**. The Cleveland Alumni Association awards the Sarah Porter Bosworth Scholarship to a graduate of a secondary school in the Greater Cleveland area. The student must have a cumulative grade point average of 3.0 or better and reside on campus.





Class of 1933 Scholarship

To assist students in their pursuit of higher education and to support the College, Lake Erie College's class of 1933 established the **Class of 1933 Scholarship**.



Cleveland Club Scholarships

The Cleveland Alumni Association of Lake Erie College awards **Cleveland Club Scholarships** annually. The awards are given to students who graduate from Cleveland area high schools. These students must have achieved a 3.0 grade point average or better and must reside on campus.

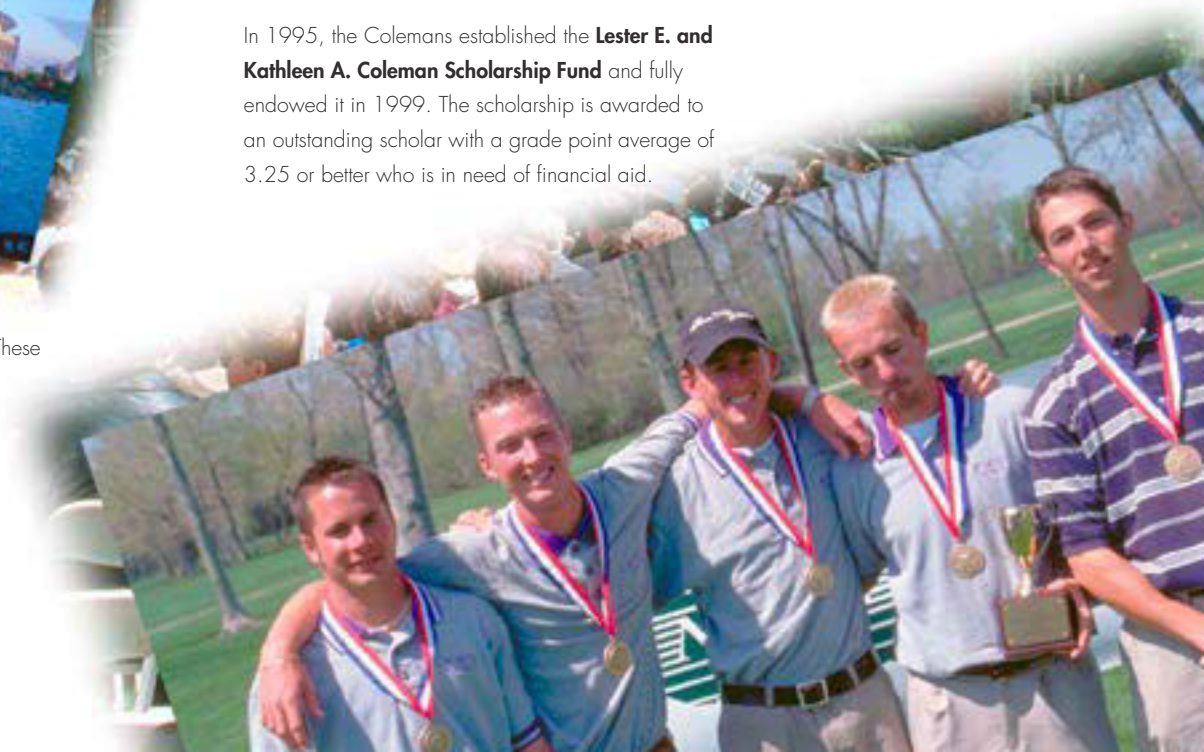


During his 40-year career at the Lubrizol Corporation, Dr. Lester E. Coleman was a research chemist, assistant division head, assistant to the president, vice president for international operations, executive vice president, president, chief executive officer and chairman. He retired from Lubrizol in 1996. He earned a B.S. in chemistry from the University of Akron. He received his M.S. and Ph.D. in chemistry from the University of Illinois. Dr. Coleman also earned a M.A. from Dartmouth College.

Lester E. & Kathleen A. Coleman Scholarship Fund

Dr. Coleman earned more than 200 U.S. and foreign patents, and he authored many articles in chemistry, research, and corporate management. For more than 35 years, Dr. Coleman actively supported the Boy Scouts of America; this support included his service as a member of the executive board of the Greater Western Reserve Council and the National Executive Board. In 1995, Dr. Coleman received an honorary Doctor of Humane Letters degree from Lake Erie College. In October of 2000, Dr. Coleman passed away at the age of 69.

In 1995, the Colemans established the **Lester E. and Kathleen A. Coleman Scholarship Fund** and fully endowed it in 1999. The scholarship is awarded to an outstanding scholar with a grade point average of 3.25 or better who is in need of financial aid.



Ellen Elizabeth Cook Memorial Scholarship Fund

Ellen Elizabeth Cook graduated from Lake Erie College in 1957 with a major in art. She studied ceramics and painting at the Carnegie Institute of Technology. Ellen began her career as an art teacher at Wilkins Junior High School in Pittsburgh, Pennsylvania. In 1962, Ellen died in a drowning accident; she was 26.

Through the generosity of Ellen's family and friends, the **Ellen Elizabeth Cook Memorial Scholarship Fund** was established in 1962. The scholarship is awarded each year to a fine arts student.



J. A. Christian Crislip Scholarship

Jeanette Crislip received her master's degree in education from Lake Erie College in 1973. Jeanette spent 32 years teaching in the local school systems and is a Painesville Township trustee. For 42 years,

her husband, Jack Crislip, worked within our community at Uniroyal in Fairport Harbor. Prior to his death at age 41 in May 1993, Joseph Crislip, Jeanette and Jack's son, served the Department of the Interior in Washington, D.C.

Joseph was an active volunteer with a number of environmental organizations and had a strong interest in helping people. He was raised in Perry and Painesville townships and graduated from Riverside High School. Joseph received his bachelor's degree in theater from Ohio State University and his master's degree in public administration from Southeastern University.

In 1996, Jack and Jeanette Crislip established the **J. A. Christian Crislip Scholarship** in memory of their son. It is awarded annually to an upperclass fine and/or performing arts major with a minimum cumulative grade point average of 3.0.

Samuel M. Cowling Scholarship



After 30 years of service to Lake Erie College as a Professor of English, Dr. Samuel Cowling retired in December 2001. To honor Dr. Cowling's work with students, Deborah Potts established the **Samuel M. Cowling Scholarship** on the occasion of his retirement. To receive this scholarship, students must have demonstrated need, a minimum cumulative grade point average of a 3.0, and be majoring in one of the disciplines within the liberal arts.

Robert Dickinson Scholarship Fund

Robert Dickinson was a member of the Board of Trustees of Lake Erie College from 1970 to 1988, and from 1983 to 1988, he served as the chairman of the board. Robert still serves the board as an honorary trustee. He has been very supportive of the equestrian center, serving as board director, patron, and donor of horses.

The **Robert Dickinson Scholarship Fund** was established in 1984. The scholarship is awarded to an equestrian student with good academic standing who demonstrates financial need.



Tracy Harrington Dickinson Scholarships

Tracy Harrington Dickinson is a 1978 graduate of Lake Erie College. She currently serves the College as a member of the Board of Trustees. She worked in health-related occupations for a number of years near her home in upstate New Jersey. Tracy has been active volunteer with the National Endometriosis Association and other organizations for much of her life.

Tracy Dickinson has made significant contributions to the College for the preservation of the College Hall tower, construction of the Holden Center, and establishment of the Harold Fink Endowed Memorial Music Scholarship Fund. Tracy has also endowed several scholarships in her own name.

The Tracy Harrington Dickinson Environmental Science Scholarship Fund, established in 1994, is awarded each year to a freshman female who is majoring in environmental science.

The Tracy Harrington Dickinson Liberal Arts Scholarships, established in 1990, recognize the exemplary liberal arts background Tracy received at Lake Erie College. Two of these endowed scholarships are awarded each year to a freshman and junior female student. These students must be majoring in a non-scientific discipline within the liberal arts. Two of these endowed scholarships are awarded each year to a sophomore and senior female student who is majoring in a discipline in the sciences, including equestrian studies. Each award recipient must have a cumulative grade point average of 3.0 or better.



Harold Fink Endowed Memorial Music Scholarship Fund

From 1952 to 1987, Dr. Harold Fink served as head of the music and fine arts departments at Lake Erie College. As a pianist, composer, and conductor, Dr. Fink presented numerous solo recitals at the College and throughout the country. He served as musical director for a variety of northeast Ohio arts organizations, judged the Metropolitan Opera auditions for eight years, composed six operas, and was associated with the Cleveland Orchestra for over 20 years. As a teacher, Dr. Fink inspired countless numbers of students with his enthusiasm and love of life.

Through gifts from alumni and friends, Lake Erie College established the **Harold Fink Endowed Memorial Music Scholarship Fund** in memory of Dr. Fink. The Fink Scholarship is presented each year to a student who has demonstrated exceptional qualities in the pursuit, study and performance of music at the College.



David French Memorial Scholarship Fund

David French came to Lake Erie College in 1968 as assistant professor of history. In 1975 he was made dean of the faculty (later provost) and was appointed full professor of history in 1976. He remained at LEC until 1982 when he resigned to join the faculty at New England College in Henniker, New Hampshire. David was also a poet, and two volumes of his poems were published during his years at the College.

David died in 1989 at age 53. Friends and colleagues established the **David French Memorial Scholarship Fund** in order to perpetuate his name and influence at Lake Erie College. David French Scholarships are awarded annually to students who are majoring in a discipline within the liberal arts.

Betsy J. Frost Endowed Scholarship Fund

In 1938, Betsy J. Frost earned a bachelor of arts in government degree from Lake Erie College. Betsy spent most of her career in the area of personnel administration. For 23 years, she served the NRM Corporation of Akron, Ohio as the personnel manager. She retired from B. F. Goodrich in 1975 as supervisor of office and clerical employment. Betsy was active in the Lake Erie College Alumni Association; she received the LEC Distinguished Alumni Award in 1979. Betsy J. Frost passed away in 1988.

Through her bequest, Betsy established the **Endowed Betsy J. Frost Scholarship Fund** in 1989. The scholarship is awarded each year to a student in any field with a minimum cumulative grade point average of 3.0.



GAR Endowed Scholarship Fund

Galen Rousch was the principal founder and chief executive of Roadway Express, Inc. He and his wife Ruth were lifelong residents of Akron, Ohio, and they were devoted to philanthropic institutions of the northeast Ohio area. In 1967, Galen and Ruth Rousch established the GAR Foundation.

Through a gift from the GAR Foundation, Mr. and Mrs. Rousch established the **GAR Endowed Scholarship Fund** in 1978.

GAR Foundation Scholarships are awarded annually to students residing in northeast Ohio with a minimum cumulative GPA of 3.5. They must be majoring in business and have a demonstrated financial need.

Catherine L. Gates Scholarship

In 1945, Gertrude F. Gates and Florence Henderson established the **Catherine L. Gates Scholarship**.

Catherine Gates was a close friend of Florence Henderson and the sister of Gertrude Gates. Catherine graduated from Lake Erie College in 1895, and served the College as head of the Mathematics Department.

Lake Erie College awards this memorial scholarship each year to a promising woman. The recipient must have a good academic record and have attained junior status.





The Gold Award

Etta Gilbert Ellenberger attended Lake Erie College for two years as a member of the Class of 1925. Etta and her husband Frederick Herman lived in an oceanfront home in Delray Beach, Florida. However, the Ellenbergers spent a great deal of time traveling throughout the world. She died in 1986, and her husband died in 1991.

The Gold Award is Girl Scouting's highest honor, comparable to an Eagle in Boy Scouts. Etta Ellenberger established the award in 1984 as a way to combine two of her greatest interests – Lake Erie College and Girl Scouting. The scholarship is presented annually to a Lake Erie College student who has received the Gold Award of the Girl Scouts of the USA.

The Arthur Holden 2 + 2 Scholarship

Arthur S. Holden is a philanthropic and community leader in northeast Ohio and has been a good friend to Lake Erie College for many years. He received an honorary Doctor of Business Administration degree from Lake Erie College in 1987 and provided leadership in funding the construction of the Arthur S. Holden Center. Mr. Holden was the catalyst behind the establishment of the 2 + 2 Scholarship program for students transferring to LEC from Lakeland Community College.

The Arthur Holden 2 + 2 Scholarship is presented to students transferring to Lake Erie College from Lakeland Community College. These students must have a minimum 3.0 cumulative grade point average.



Sarah Almira Greer Scholarship Fund

Sarah Almira Greer graduated from Lake Erie College in 1862. From 1863 to 1875, she served as a faculty member at the College. Sarah represents the first of five generations to graduate from Lake Erie College; these alumni include her daughter Lucy H. Treadwell, class of 1898- granddaughter, Jessie Treadwell Ray Anderson, '26- great-granddaughter, Barbara Blair Anderson Brown '55- and greatgreat-granddaughter, Blair Brown Bowers, '84.

In 1956, Jessie Treadwell Anderson established the **Sarah Almira Greer Scholarship Fund**. Jessie endowed the fund in 1985. Sarah Almira Greer Scholarships are awarded each year to senior students who have a financial need.



Helen Gertrude Ingersoll Scholarship

Through her bequest, Miss Ingersoll established the **Helen Gertrude Ingersoll Scholarship**. Miss Ingersoll's intention was to assist graduates of Greater Cleveland area high schools in their pursuit of higher education. Students receiving this award must have shown excellence in academics.



Mildred James Scholarship Fund

Mildred James graduated from Lake Erie College in 1921 with majors in biology and chemistry. She received her master's degree in education from Simmons College. For several years, she was involved in religious education. Mildred spent the majority of her life caring for her parents on their farm in Burton, Ohio. In 1977, Mildred died at the age of 78.

Through a bequest, Mildred established the **Mildred James Scholarship Fund** in 1977. The Mildred James Endowment Trust provides this fund with additional distributions each year. The scholarship is given to a worthy female student to help with educational expenses.

James D. Klucher Scholarship Fund

From 1991 until his death in 1993, James D. Klucher was an associate professor of education at Lake Erie College. Before joining the faculty of LEC, Dr. Klucher was an administrator in the Mentor Schools. Dr. Klucher was also the first executive director of Lake Educational Assistance Foundation, Inc. (LEAF).

In 1994, friends and relatives established the **James D. Klucher Scholarship Fund** in memory of Dr. Klucher. This scholarship is awarded annually to graduates of Mentor High School who become undergraduate elementary education majors (preferably male students); to maintain the award, the students must be in good academic standing.



Ladd-Higgins Scholarship

Martha Brewster Higgins was a supporter of arts education and Lake Erie College. Through a 1955 bequest, she established the **Ladd-Higgins Scholarship**. This scholarship is awarded each year to a student pursuing studies in music.



Laub Foundation Scholarship Fund

Herbert J. Laub and his sister Elsie K. Laub of the Laub Baking Company, established by their father, incorporated the Laub Foundation in 1958. The foundation received its principal funds in 1968 and 1970 from the estates of Mr. and Miss Laub.

The **Laub Foundation Scholarship Fund** was established in 1979 through a gift from the Laub Foundation. Annual grants from the foundation allow Lake Erie College to continue this fund. Laub Foundation Scholarships are awarded annually to students in good academic standing who are residents of northeast Ohio.



Lincoln Memorial Scholarship Fund

James F. Lincoln, founder and chairman of the board of the Lincoln Electric Company, served Lake Erie College as a trustee for 27 years and as president of the board from 1952 until his death. Through his life, Mr. Lincoln anonymously provided funds to enable deserving students to pursue a college education. He also generously supported a variety of programs and building projects at the College.

Mr. Lincoln's first wife, Alice Josephine Patterson, attended Lake Erie College from 1901 to 1902. The couple was married from 1908 until Alice's death in 1954, and the Lincoln Commons was dedicated to her memory in 1959. Mr. Lincoln married Jane D. White in 1961. Following his death in 1965, Jane White Lincoln remained a good friend to the College. The Lincoln Library is dedicated to her.

Friends of Mr. Lincoln endowed the **James F. Lincoln Memorial Scholarship Fund** in 1965. The scholarships are presented each year to female students who are involved in extracurricular activities and demonstrate financial need.

Ella Schulz Lynn Scholarship

Ella Schulz Lynn graduated from Lake Erie College in 1936. After a fruitful career as an international trade specialist, she retired from the U.S. Department of Commerce in Miami. During this time, she also developed and taught coursework in export and import practice at a Florida vocational school.

While at Lake Erie College, Ella Schulz Lynn majored in Latin with minors in French and Spanish. Throughout her career, Ella found that the liberal arts and expertise in languages were important in all her positions. To help young women gain access to this type of education, Ella endowed the **Ella Schulz Lynn Scholarship** in 1990. It is awarded annually to an incoming freshman female who shows promise of distinction in her chosen field in the liberal arts and who is in need of financial assistance.



The Masten Award Fund

Edith Virginia Enkler graduated from Lake Erie College in 1936 with majors in French and German. She received her master's degree in romance languages from Western Reserve University and also studied at La Sorbonne in Paris. For 45 years, Virginia taught French, German and Spanish in the Cleveland Public Schools; during her tenure, she served as chair of the foreign language department at East High School. Virginia also served the Cleveland College and the Demonstration School of Foreign Languages at Western Reserve University as a member of their teaching faculties.

Virginia spent many years as a member of the Cleveland Orchestra Chorus and several church choirs. She enjoys attending musical and theater performances in Playhouse Square and University Circle in Cleveland. For many years, Virginia has donated playbills to Lake Erie College.

In memory of her grandparents, Mr. and Mrs. Isaac Parey Masten, and her mother, Mrs. Edith Ann Masten Enkler, Edith Virginia Enkler established **The Masten Award Fund** in 1966. The scholarship is awarded each year to a member of the junior class for outstanding achievement in the study of modern foreign languages, preferably French.





Mastin Scholarships

During Dr. Thomas W. Mastin's successful, 40-year career with the Lubrizol Corporation, he earned 20 patents and worked his way from research chemist to president and chairman of the board. Following his retirement in 1982, Dr. Mastin directed his energy towards nature and conservation efforts.



He served on the Lake Erie College Board of Trustees from 1974 through 1983 and was an Honorary Trustee from 1993 until his death in 1998. At Lake Erie, he established the Environmental Sciences Resource Information Center (ESRIC). His efforts were instrumental in beginning the major in environmental sciences.

Tom Mastin funded four annual scholarships for science students for a number of years and endowed this scholarship fund in 1994. **Mastin Scholarships** are presented each year to incoming science majors who have high composite ACT or SAT scores and a minimum 3.0 cumulative grade point average. Provided that the recipients maintain 3.0 grade point averages and remain science majors, these scholarships are renewable for three years.

Martha Harrison Mayer Scholarship

Martha Harrison Mayer was a 1922 graduate of Lake Erie College with a major in math. She raised and raced harness horses and was a volunteer with a number of organizations until her death in 1973. Her husband, Bruce Mayer, was a bank executive.

Through her bequest, Mrs. Mayer established the **Martha Harrison Mayer Scholarship** in 1974.



Clara Elma Maythem Scholarship

Through her bequest, Clara Maythem established the **Clara Elma Maythem Scholarship** in 1948. To assist graduates of secondary schools in the Greater Cleveland area, the Cleveland Alumni Club awards this scholarship each year.

McIntyre Scholarships

Jeannette C. McIntyre was a businesswoman who believed in the value of hard work and organization. She served for 14 years as president of LEECO Corporation, a local manufacturing business founded by her husband Frederick. After the sale of that company to Corn Products Corporation International in 1985, Jeannette moved to Palm Springs, California, where she opened and operated an art gallery.

The Jeannette C. McIntyre and Frederick (Lash) McIntyre Charitable Foundation Trust was established upon Jeannette's death in 1994. Through funds donated from the trust, the College awards **McIntyre Scholarships** each year to upperclass students majoring in business. These students must carry a minimum 3.0 grade point average.

Katharine K. Meister Prize

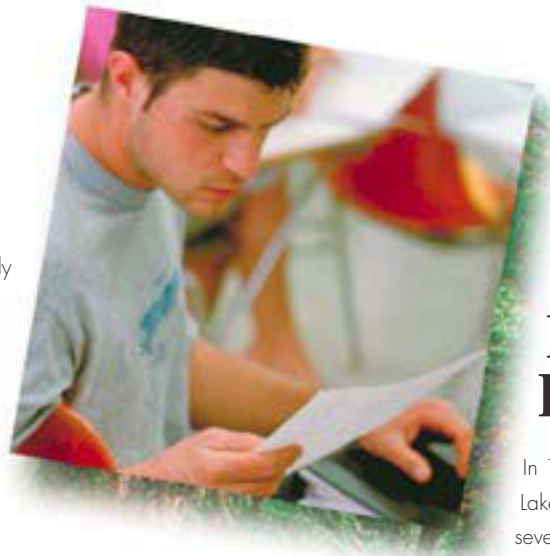
To honor the memory of his wife, Edward L. Meister established the **Katharine K. Meister Prize** in 1976. Katherine King Meister tragically died 33 days after graduating, with highest honors, from Lake Erie College in 1976. This cash award is presented annually for excellence in literary composition.



Lena G. Norton Scholarship

Lena G. Norton graduated from Lake Erie College in 1889. From 1891 to 1895, she served the College as a teacher and librarian. After 1895, Mrs. Norton pursued a nearly lifelong career as an instructor in mathematics. She lived in Claremont, California.

As an expression of gratitude for the aid she received as a student, Mrs. Norton established the **Lena G. Norton Scholarship** through a 1955 bequest. This scholarship is given annually to a senior who has done outstanding work in mathematics during their first three years in college.



Edward E. and Alice R. Powers Higher Educational Trust

In 1929, Alice Resch Powers earned a Bachelor of Arts degree from Lake Erie College. She worked in personnel and fashion coordinating for several New York City department stores. During her career, Alice was the assistant sportswear buyer for Montgomery Ward and personnel director of J. B. Ivey & Co., a Charlotte department store.

Alice's husband of 40 years, Edward W. Powers, was a jeweler and stockbroker. The couple was instrumental in restoring the former Warner Theatre in Youngstown. The theatre now is named the Edward W. Powers Auditorium. The auditorium is home to the Youngstown Symphony.

Alice was very happy to sponsor the SCOPE program at Youngstown State University. This program provides promising high school students a summer-time experience of going into college and entering a profession. Alice delivered the commencement address at Youngstown State University in 1988, at which time, she received the Honorary Doctor of Laws degree.

Alice and her husband established the **Edward E. and Alice R. Powers Higher Educational Trust** to provide student aid and improve the quality of education at Lake Erie College and six other schools. The College regularly receives support from the trust, which provides scholarships for deserving students from Mahoning and Trumbull counties.

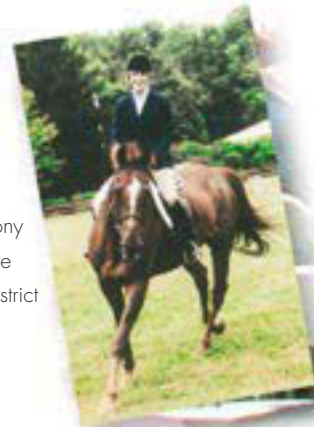


OFIC Scholarships

The Ohio Association of Independent Colleges funds numerous **OFIC Scholarships**. The OFIC carries out annual campaigns and designates the funds to support students who attend member institutions. Aside from a student's attendance at a member institution, the OFIC establishes criteria for each award.

Jerome T. Osborne, Jr. Scholarship Fund

In 1992, the **Jerome T. Osborne, Jr. Scholarship Fund** was established in memory of Jerome T. Osborne, Jr., who supported Lake Erie College in many ways. This scholarship is awarded to a Lake County resident who is involved in either the Lake County community or the Lake Erie College community. The student must be in good academic standing and demonstrate financial need.



Pony Club Scholarship

The **Pony Club Scholarship** is for members of United States Pony Clubs, Inc. who major in equestrian studies. Students must have above-average grades and be recommended by the USPC District Commissioner.



Edna Cope Quine Scholarship

As residents of Painesville, Edna Cope Quine and her husband enjoyed attending fine arts programs at Lake Erie College. At one time, they contributed to the College for the refurbishment of Morley Music Hall. The Quines considered this building to be one of the most beautiful in the United States.

In memory of his wife, Kenneth Quine endowed the Edna Cope Quine Fine and Performing Arts Scholarship in 1990. The **Edna Cope Quine Scholarship** is awarded annually to an outstanding incoming freshman who plans to major in the fine or performing arts. In addition to showing promise of distinction, the student must demonstrate financial need.

Mabel Marsh Ritchie Scholarship Fund

Mabel Elsie Marsh Ritchie came to Lake Erie College from her home in Tallmadge, Ohio and graduated in 1901. She spent some years as a teacher in New York, Georgia and Ohio. In 1935, Charles E. Ritchie, Mabel's husband, began a six-year tenure as mayor of the newly incorporated Tallmadge.

The first gift to Lake Erie College from the Charles E. & Mabel M. Ritchie Memorial Foundation of \$7,500 was made in 1957. This gift was designated for the establishment of the **Mabel Marsh Ritchie Scholarship Fund**. This scholarship, now endowed, is awarded annually to an outstanding student from northeast Ohio who shows promise of distinction and who is in need of financial aid. The student must have an accumulated grade point average of 3.0 to be considered for the award.



Catherine Roddick Endowment Fund

Catherine Roddick was the last member of a long-time Painesville family. She was interested in Lake Erie College and wanted to help local students. Through a gift from the Roddick Fund, Catherine established the **Catherine Roddick Endowment Fund** in 1992.

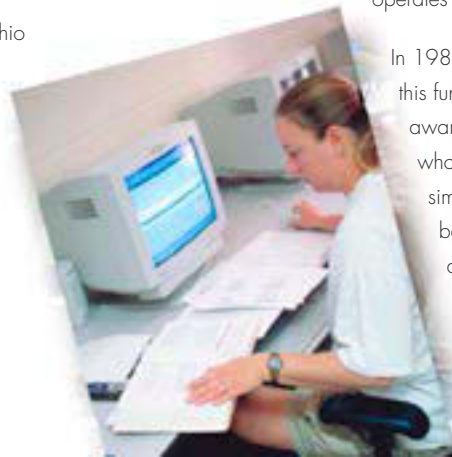
The Roddick Fund continues to provide money for this scholarship program each year. According to the wishes of Catherine Roddick, Lake Erie College awards these scholarships to deserving students from the Painesville area.



Roemisch Research Foundation Award Fund

Elizabeth Roemisch holds the concept of entrepreneurship in high esteem. Mrs. Roemisch is also a long time supporter of Lake Erie College. Her daughter, Elaine R. Crane, owns and operates Lake County's historic Riders Inn.

In 1981, the **Roemisch Research Foundation Award Fund** was established; this fund is supplemented annually through gifts from Elizabeth Roemisch. The award is given annually to a junior or senior student (preferably a female) who is majoring in business, economics, pre-law, or a similar business-service oriented field. The student must be working toward starting a small business venture and must have financial need.



John S. Roscoe Memorial Scholarship Fund

All who knew John S. Roscoe held him in high esteem. He was a director for the Lincoln Electric Company. John died suddenly in 1979.

In 1979, friends of John established the **John S. Roscoe Memorial Scholarship Fund**. The scholarship is presented annually to students whose grades are average or better and who have achieved success within the limits of their capacity.



Catherine F. Shaw Athletic Performance Scholarship

From 1954 to 1987, Catherine F. Shaw was head of the department of physical education at Lake Erie College. Although retired, she continues to serve the College as professor emeritus. Catherine Shaw is well known in the community as an active volunteer.

On the occasion of Catherine's retirement in 1990, the College established the endowed **Catherine F. Shaw Athletic Performance Scholarship**. Alumni, students, and friends of the College regularly provide gifts to the scholarship fund. Scholarships are presented annually to qualified women leaders.



Tessie Mae Seamon Scholarship Fund

Tessie Mae Seamon graduated from Lake Erie College in 1956 with majors in sociology and psychology. After receiving her master's degree in social work from Western Reserve

University, she worked as a faculty member, counselor, and social worker at the University of Toledo.

Miss Seamon established the **Tessie Mae Seamon Scholarship Fund** in 2000. The scholarship is awarded to a female student who is in her junior year at the College. She must have a minimum cumulative grade point average of 2.0 and major in social sciences, psychology, biology or chemistry. The student must show promise of academic success, have legitimate financial need and plan to work in health or human services after graduation.



Mary Krehl Stillwagon Scholarship Fund

The Stillwagon family has strong ties to Lake Erie College. In 1905, Mary Krehl Stillwagon Gabrielson graduated from the College. Her daughter-in-law, Nancy James Stillwagon, graduated in 1944, and her granddaughter, Nancy Stillwagon Carstensen, graduated in 1970. Mildred Stillwagon Gabrielson is Nancy James Stillwagon's sister-in-law and Nancy Stillwagon Carstensen's aunt.

In 1988, Mildred Stillwagon Gabrielson established the endowed **Mary Krehl Stillwagon Scholarship Fund** in honor of her mother. The scholarship is awarded each year to a junior or senior history or fine arts major who has a minimum cumulative grade point average of 3.0 or better.





Harriet B. Storrs Scholarships

In memory of Sadie Storrs and three other members of Lake Erie College's class of 1901, Mrs. Mary F. Storrs purchased and provided for the installation of the Tiffany window in Memorial Hall. This window was completely installed in 1910. In 1957, a fire consumed both the window and the building.

Harriet B. Storrs Scholarships are awarded through a grant to the College from the Harriet B. Storrs Fund of the Cleveland Foundation. The scholarships are awarded to Painesville residents in good academic standing.



Ruth Warnke Scholarship

In 1927, Ruth M. Warnke graduated from Lake Erie College with a major in German and a minor in English. She took courses in psychology and education to qualify for a teacher's certificate. Following graduation, she worked as an assistant in the College's department of psychology in exchange for room and board. Ruth was an active member of the alumni association for a number of years.

In 1930, Ruth earned a master's degree in psychology from the University of Minnesota. She began her career as a psychologist in the Shaker Heights school system in 1931. Ruth retired in 1966 and passed away in 1982.

The Cleveland Alumni Association awards the **Ruth Warnke Scholarship** to graduates of Greater Cleveland area high schools. These students must have a cumulative grade point average of 3.0 or better and must reside on campus.

Emily Shedd Wales Latin Scholarship

Emily Shedd Wales graduated from Lake Erie Seminary for Women in 1869. From 1870 to 1882, she taught in Painesville and Mentor. Following her twelve-year teaching career, she married William J. Wales.

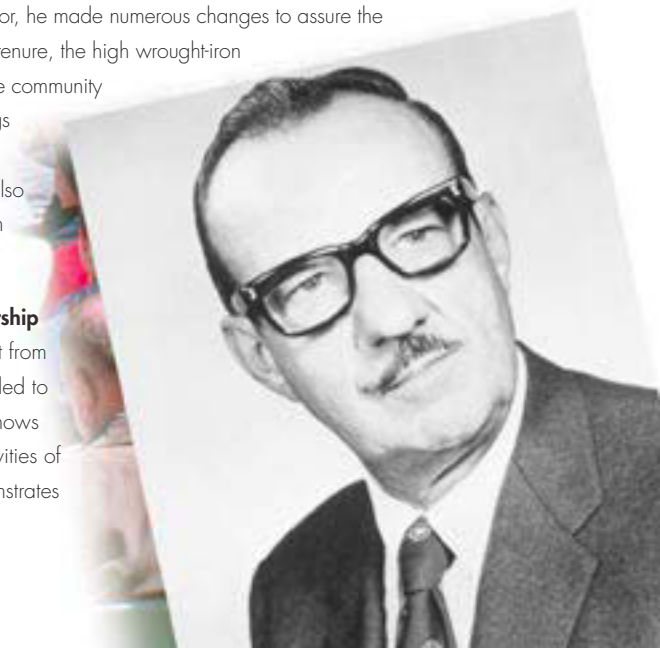
Through her bequest, Fannie Elizabeth Rich established the **Emily Shedd Wales Latin Scholarship** in 1954. These scholarships are awarded each year to an outstanding student in each of the foreign languages taught at Lake Erie College. These languages include French, German, Italian and Spanish.



The Paul Weaver Alumni Scholarship

Paul Weaver served as president of Lake Erie College from 1951 through his retirement in 1976. As the first male administrator, he made numerous changes to assure the survival of the College. During his tenure, the high wrought-iron fence isolating the College from the community was torn down, eight new buildings were erected, and Garfield Senior Center was established. Weaver also instituted the mandatory winter term abroad for all juniors.

The Paul Weaver Alumni Scholarship was established in 1966 by a gift from the alumni in his honor. It is awarded to a student with senior status who shows potential for leadership in the activities of the Alumni Association and demonstrates financial need.





Theresa Hollander Weisberger Award

Theresa Hollander Weisberger graduated from Lake Erie College in 1963. Miss Weisberger pursued majors in Spanish and English literature, and during the Winter Term Abroad, she studied in Madrid. In 1965, Miss Weisberger earned a master's degree in applied social science administration from Western Reserve University. She held various caseworker positions in Cambridge, Massachusetts, and was especially interested in problems confronting elderly people.

Through a gift from her estate, the **Theresa Hollander Weisberger Award** was established in 1990. The College grants this award to cover costs associated with the Academic Program Abroad for students with financial need.

Ruth A. Wills Endowed Scholarship Fund

Ruth Aubrey Wills graduated from Lake Erie College in 1932. During her working life, Ruth was an interior decorator, elementary school teacher, and junior high art teacher. After ten years as a children's librarian, Ruth retired. During World War II, Ruth served as a WAVE in the Intelligence Department of the U.S. Navy.

Ruth was a tremendous supporter of Lake Erie College. She served as her class agent, organized gatherings and reunions, and recommended students for admission. Ruth contributed financially to Mathews House projects and the Class of '32 Loan Fund. She also donated several Persian rugs and a valuable collection of Kasimir books and prints to the College. Ruth's second husband, Robert L. Wills, was an attorney and law professor at Ohio State University for 37 years.

Through a bequest from her estate, the **Ruth A. Wills Endowed Scholarship Fund** was established in 1989. The Ruth A. Wills Scholarship is awarded each year to a student with a grade point average of 3.0 or better who is in need of financial aid.



Margaret MacDonald Winkler Music and Fine Arts Memorial Scholarship

Jeanne Arnold Winkler graduated from Lake Erie College in 1942. She earned her law degree from Western Reserve University. Jeanne practiced law in Cleveland and Sarasota, Florida. Jeanne's husband, Eldon Winkler, was Vice President of Lake Erie College from the 1950s to 1962, and he was known as the voice for the arts in Lake County.

In memory of a former faculty member, Jeanne established the **Margaret MacDonald Winkler Music and Fine Arts Memorial Scholarship** in 1965. The scholarship is awarded each year to a junior who demonstrates the greatest development as a musician during their first two years at Lake Erie College.
